The requirements for Scholarship Review include the following:

- 1) The completed scholarship application must be returned to the church office <u>no later</u> than Monday, May 8th, 2023.
- 2) Attached to the application please include a short essay on your commitment to Christ Church Ridley Park (e.g., involvement in SS, acolyte, choir) or Church Life in general (e.g., financial example demonstrated by Mr. Deppich, volunteerism).
- 3) Send or attach an official transcript from your high school or college. Winter transcripts of grades will be accepted.
- 4) Contact a faculty member, mentor, coach (not a relative) and request a letter of recommendation.
- 5) You <u>MUST</u> submit <u>ALL</u> of the above requested information with your application or you will not be considered for a scholarship.
- 6) Please bring or mail the completed application to the Church office in a **sealed envelope** addressed as follows:

The Earle Deppich Scholarship Fund

The Earle Deppich Scholarship Fund was established by the Vestry of Christ Church to remember Mr. Deppich and to emphasize the importance that Christ Church held in his life and the lives of many others.

Applicants <u>must be affiliated with Christ Church</u>, <u>Ridley Park</u> and must have been accepted by or be attending an accredited college, seminary or trade school. Students are eligible to be awarded the scholarship for four years, but must reapply annually. The scholarship may be used for tuition, room and board, or books.

CRITERIA

The scholarship shall be awarded based on financial need, academic achievement, and commitment to Christ Church. Financial need will be determined through the applicant's written summary of the cost of education, and the amounts being contributed by the student and/ or family members and all other sources of income or financial aid. Academic achievement will be determined by high school transcript or other appropriate transcript. A written letter of recommendation from a faculty member or other person who is familiar with the student's educational record must also be submitted. This may not come from a relative. Commitment to Christ Church is defined as Communicant in Good Standing as defined in the Parish By-Laws. For students not of voting age, commitment to Christ Church will be measured by participation in church sponsored activities. The applicant is also asked to describe in a separate composition why he or she is applying for this scholarship. The student should reflect on the purpose and criteria for the scholarship fund in describing the reasons for making the application.

The student may be asked to interview with members of the selection committee to satisfy these requirements.
